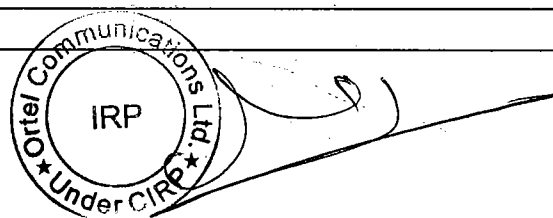

An application under Section 9 of Insolvency and Bankruptcy Code, 2016 (IBC) filed by the applicant viz Sony Pictures Networks India Private Limited against the respondent viz. **Ortel Communications Limited, which** was duly admitted by Hon'ble Adjudicating Authority i.e. National Company Law Tribunal, New Delhi Bench, (Hon'ble NCLT) on **27/11/2018** and **Mr. Anil Bhatia**, with registration number **IBBI/IPA-001/IP-P00587/2017-2018/11027** was appointed as Interim Resolution Professional (IRP).
